#### How to select witnesses.

- (b) Do they communicate in English?, if not who will serve as translator?
- (c) Experts scientific, then *Daubert* criteria. Lay experts can you lay a foundation?
- (d) Potential Customs' witnesses: scientists; import specialists, competitors.

What do you do with the time you have available on the Reserve Calendar?
